SMP Health Check Production

First tranche (March)

FEEDBACK ON SMP FORUMS

SMP Forums

Governance and use

Broad range:

- Seen as superseded by Strategies (9, 18, Humber)
- Active coastal management, but concerns about long-term view (5, 10, 15)
- Ongoing SMP engagement and active use (1, 4, 6-8, 13, 22)
- Coastal group resourcing challenges / ownership unclear (10-12, 15, 18, 19)

Use of Action Plans

- Broad range; from not at all to detailed tracking
- Often used actively initially, but....
-Difficult to keep alive & meaningful

SMP Forums

Informing decision making

- Triggers often used implicitly – many are keen to make these explicit for policy transitions
- Headline policies:
 - Often cause for confusion
 - Broad (but not full) consensus that sub-labels are useful

New evidence

- Strategies superseding SMPs
- ‘Monitoring’ Actions often carried out, but subsequent ‘Assessment’ Actions often missing
- Coastal change different than predicted (slower or faster)

SMP Forums

Planning

- SMP typically referenced in Local Plans; Planners usually involved
- Many areas with CCMA's; others want them; some are unclear
- CCMA's for HtL areas

Environment

- Predicted intertidal loss often a big driver, but evidence now uncertain
- Some localised issues with new / changed designations

Climate change

- SLR does not directly drive policy, but can influence timing
- Complex interactions (coastal squeeze, habitat loss) used as firm drivers in SMP2, but very uncertain and not firmed up since

SMP Forums

Shared issues

- Contaminated land constraining policy (2, 3, 8, 13, 18, 22)
- Dealing with loss of property and infrastructure
 - Being addressed (with challenges) in some places (3, 6, 7)
 - Various cases where MR in Epoch 2 has been overruled since SMP2 (8, 11)
- Funding
 - Challenges (expensive HtL; but also expensive MR cases)
 - Good examples of RMAs supporting efficient HtL by land owners
 - GiA economics constrain RMAs in supporting communities to adapt
- Private defences – how to enforce policy
- Issues with accessibility of the documents
- Large PUs with multiple policies
